This upgrade included replacing most of the main cable line between Palestine and Elkhart and in the City of Elkhart. The citizens of Elkhart now enjoy the same quality of cable TV as Palestine. Over the past six years, labor, utilities, equipment, materials, supplies, copyright fees and other operating costs have all increased significantly. These increases have been absorbed by Group W Cable since 1980 without passing these increases on to our customers. All of the above mentioned factors have increased the cost of furnishing cable television service. Yet the rate of \$7.75 charged for basic cable service has remained the same since February 1980. Group W Cable operates as a service to the public, but must also be allowed to realize a fair return on its investment. Although we have made every effort to control the costs of operating our business while improving service to our last year. We respectfully request City Council approval to increase the monthly service charge for a primary outlet of basic cable service to \$9.50 as of January 1, 1986. We also propose to adjust the monthly charge of additional outlets from \$1.50 to \$2.00 per month. These adjustments would make the

basic cable rates in Elkhart the same as those currently being charged in Palestine."



Public Hearing that are required by State Law in order to submit an application for a Texas Community Development Grant. The purpose of the first hearing is to solicit your views and comments concerning the possible uses of grant funds should they be able to be obtained. In order for you to make those comments we have provided you some written information as to the activities that these funds can be used for.

After hearing your comments at this Public Hearing, an application will be developed, and after the second Public Hearing, the City Commissioners will be asked to consider a resolution which authorizes the actual submission of the grant application. The presentation at the second Public Hearing will actually include the project as it has been developed as a result of your participation here today, your comments and questions.

One of the first things we would ask that you do is sign the attendance list. The attendance list asks for your name, address, and telephone number and we ask that you please give us this information on each of you. Please be sure and sign it so that we will have a record of the attendance.

The second thing we have for you is a program summary. This is a summary of the 1986 Texas Community Development Program taken from the 1986 Procedures Manual prepared by Texas Department of

Community Affairs, April, 1986. We feel that this will provide you some helpful information about this program, who can apply for the funds, and what those funds can be used for.

The goal of the Texas Community Development Program is the development of viable communities by providing decent housing and a suitable living environment and by expanding economic opportunities, principally for persons of low and moderate income.

 $\qquad \qquad \text{the four objectives of the Texas Community Development} \\ \text{Program are:}$

- To improve public facilities to meet basic human needs, principally for low and moderate income persons.
- to improve housing conditions, principally for persons of low and moderate income.
- To expand economic opportunities that create or retain jobs, principally for low and moderate income persons.
- 4. To provide assistance and public facilities to eliminate conditions hazardous to the public health and of an emergency nature.

We will be required to deliver to the Texas Department of Community Affais, which administs this program, a completed application to their office in Austin no later than 5:00 p.m. on the 30th day of June. It may seem that we have a considerable amount of time to work with, but we are actually on a pretty tight time schedule.

In terms of eligible activities, all proposed activities must meet at least one of the three national program objectives which are a part of the Federal Housing and Community Development Act, which was passed by Congress in 1974, and initially authorized the monies for this program.

The three national program objectives are:

- 1: Benefit low and moderate income persons. (At least fifty-one percent (51%) of the identified beneficiaries must have a family income of less than 80% of the area median income.)
- 2: Aid in the prevention of elimination of slums and blight.
- 3: Meet other community development needs of particular urgency which represent an immediate threat to the health and safety of residents of the community.

There are certain activities that this money may \underline{not} be used for. Often times it is easier to talk about what you can \underline{not} use this money for rather than what you can use it for. In general, any type of activity not described or referred to in .

the Federal Housing and Community Development Act of 1974, is ineligible for consideration for funding. Specific activities which are ineligible under the Texas Community Development Program include:

- A: Construction of buildings and facilities used for the general conduct of government such as: city halls, courthouses and jails. One exception is improvements(s) made to these buildings solely to provide complete access for handicapped individuals which is an eligible TCDP activity.
- B: New housing construction, except in cases of replacement housing when individuals are displaced by TCDP funded activities.
- C: The financing of political activities.
- D: Purchase of construction equipment.
- E: Income payments, such as housing allowances.
- F: Most operation and maintenance expenses.

I call you attention to the page in the packet we provided to you entitled "Eligible Acitivities" (page (3)). This lists the eligible and ineligible activities under different types of projects. As you can see, there are specific activities which can and can not be done. I might also add, in addition to these traditional public work projects, these funds can be used for park and recreation improvements and storm drainage improvements, certain types of multipurpose centers, and fire protection.

The way this program works is that once the application has been developed, written, and submitted, the application will be scored. Based on that numerical score, a ranking of projects within this region will occur. Based on the amount of funds allocated to this region, the numerical scores will produce a rank order, and from that rank order the State will develop the ranking order list and fund the most highly ranked projects until the funds have been exhausted. And here within the East Texas Region there is approximately \$1,796.453 available this year for competition.

The scoring system used is two step. First, the Regional Review Committee (which is made up of 12 local elected officials appointed by the Governor from this region scores selection factors related to project design. Secondly, the State scores the application related to community distress, benefits to low/moderate income persons, minority hiring, and continuation of need. The sum of the two scores result in the total score and it is that score used to rank the project.

Within this region an applicant is eligible to seek a maximum of \$300,000 under this program and may not request less than \$50,000. We feel that as consultants, one of our jobs is to help

produce an application which will have the best possible chance of approval. We believe that the level of funds requested may sometimes have a bearing on the chance the project will be approved or not. For example, we feel that if the applicant were to ask for a \$500,000 grant, the chances of it being approved would not be as great as if it had asked for a grant half that large. Although there are exceptions to all kinds of opinions, I think that one will hold true in most cases.

We also believe that based on the way the program is set up now, there will be an attempt by the State and the Regional Review Committee to see that Cities or Counties which have never before received this money have a fair chance to receive it, or which have gone several years without receiving a grant may be able to receive a grant under this program.

I have given you a bit of information in a short period of time. If any of you have questions about the program, I would be glad to answer any general questions about it or if you have any questions or comments regarding projects that you are here to speak in favor of, then now is the time to do so. I think the best way would be to recognize each individual who wishes to speak separately, and give each person a reasonable amount of time to speak. So at this time if you would please stand and before you make your comments would you please stand and identify who you are.

Virgil Simpson: Yes.

Lavoy Lasiter: Who makes the decision on who gets the grant?

Virgil Simpson: The decision depends on the count of who

gets the points on the income areas. Lack of points knocks you

down. Urgent Needs grant can be obtained if there is a real need

there or if the people can help themselves you will not get the grant.

Jimmy Parker: The East Texas Council of Government grade it and makes their recommendations forward it on to the State and then they grade it themselves.

Lavoy Lasiter: They make the decision and then the Federal Governments gives them their money.

Jimmy Parker: Most of the time the East Texas Council of Governments decision and the State's decision are different.

Lavoy Lasiter: How much are you asking for?

Virgil Simpson: The Wastewater Grant was for \$301,000. The water, that is what we will decide when we get an engineer and the engineer will figure out how much the cost will be.

Lavoy Lasiter: Do you have to specifiy a certain number of miles of pipes and how things are to be broken down or is the grant given on and the City may do what it wants with it?

Virgil Simpson: It will have to be broken down on certain areas. The area you have applied for is the area you have to go with. This is like the wastewater grant; there was nothing put in for the sewer plant so the money cannot be used for it. That will have to come from another source. I have asked about elevated storage but that would serve all the areas and all areas are not eligble because of the low to moderate income. Therefore any grant money must be used for what the grant was applied for.

Lavoy Lasiter: Do you have to hold two public hearings? Virgil Simpson: Yes, this is our second public hearing.

Jimmy Parker: The first public hearing was held on the 7th day of May. On this grant application, I would like to point out that the State pinpoints where you can apply these funds. But by no means is this project the only problem we have in Elkhart. We are trying to solve the problems in the other parts of town on our own, we are trying to apply for it through the grant. Since they have been pinpointed in these areas we are trying to use them along with our own resources. But by no means is that the only problems we have in this town without water and sewer either one.

May 21, 1986 on presentation by Ultsch Engineering - My name is Rick Ultsch with Ultsch Engineering. Personal background: I have been in the Elkhart area 14 years, worked with Johnson Engineers since 1977, I specialist in water and wastewater systems. Preliminary

figures for water improvements for a fire rated system.

Average growth of Elkhart: 24 meters/year (year 2006 = 1442 meters). Fire Insurance: Key rate \$.92 (Palestine \$.19).

Wells: Existing Primary = 332 gpm. Existing Backup = 190 gpm (originally tested at 300 gpm), I recommend no new well drilled. Put backup well on line and upgrade both existing wells as growth dictates (slightly deficient per Health Department; okay with Board of Insurance).

Service Pumps: Existing Pump 1 = 300 gpm. Existing

Pump 2 = 300 gpm. Existing Combined - 500 gpm (Pump 1 and 2

running together). I recommend upgrading with two new service

pumps rated at 1000 gpm combined (satisfies Health Department and

Board of Insurance for 20 Year +).

Storage: Existing Ground = 51,000 gallons. Existing Elevated = 55,000 gallons. I recommend adding an additional 150,000 gallons elevated storage (satisfies Health Department total storage requirement for 17 years and Boar of Insurance elevated storage requirement for 20 years).

Distribution: Existing system has excessive small diameter pipe. I recommend adding 78 fire hydrants and almost 10 miles of waterline. This would provide fire protection to entire city limits and allow for growth. (Board of Insurance requires minimum of 600 ft. residential areas and 300 ft. in commercial areas).

Cost for a complete fire rated system, including backup well on line, providing service pump capacity of 1000 gpm, 150,000 gallon elevated storage, fire rated distribution, and cost for land, legal, capital cost. Also without a complete fire rated distribution system, the "bare-bones" project would be \$461,000 total capital cost.

Financing through FmHA for 40 years at 7 1/8%. 1986 average monthly water bill per meter = \$8.58 (existing).

Proposed average bill to retire bonds = \$11.93 (proposed). This would increase average bill \$3.35 per month or \$40.00 per year.

If the city changed from fire unprotected to protected, this cost could be partially recovered by reduced fire insurance premiums (\$18.00 per year for \$50,000 home).

Edwin Lively: Can the elevated tanks be located on top of a hill or be set up on a hill?

Rick Ultsch: Yes, the higher you go up with the tank the more expensive it is. I have looked at several different areas specifically Montgomery Road and stated that it would work as a site for the storage tanks. It is workable site for 20 or 30 feet higher than the natural ground here in existing but there are several possible of where it can be placed.

Tom Goggans: 332 gpm and 190 gpm is ability of our pumps and this 1,000 gpm is that the requirements now or the requirements in 20 years?

Rick Ultsch: Yes, this is the ability of the pumps and the requirements for now and next 20 years. What they are saying is 2 gpm per connection or 1,000 max. The law requires you 1,000.

Tom Goggans: Two pumps tied together now 500 gpm so we have half of the pumping capacity today?

Rick Ultsch: On your booster pumps. The wells and the pumps are two different items. Your well pumps empty into the storage tanks and then your booster pumps take it out of your tanks and put it into your system.

Tom Goggans: We only have 50% of our pumping capicity on service pumps, not out of the wells but the tanks?

Rick Ultsch: Yes. The wells are based on 6/10 of gpm per connection but the service pumps are based on 2 gpm with a maximum of 1,000 combined. I wouldn's recommend going to a new well to fit our needs, I think we can upgrade these sufficiently to meet our needs since we are not using the backup well, we are only using the existing well. We can more or less double our capacity from our past experience.

Edwin Lively: Elevated storage - Say we did use the Montgomery Street Site and it is 20 to 30 feet hgiher, do you have any idea what the kind of pressure that it would give us?

Rick Ultsch: The minimum pressure would be 35 pounds under normal conditions but under extreme conditions it might be 20 pounds.

Milo Pennington: What if we went for the whole project and then one of the wells would play out and we could not fix the well, would we have to have a new well?

Rick Ultsch: That could happen on any system.

Presentation: Johnson Engineers - I am Mco Johnson with Johnson Engineers. We have 3 engineers, 2 techniances and 2 office personnel.

References: City of Elkhart, City of Palestine and City of Buffalo.

Information sources: Health Department, your staff and the TDCA report for 1985. The supply for 966 meters using the Health Department guidelines you will need right at 580 gallons per minute supply. You have now Well No. 2 300 gpm and Well No. 3 190 gpm for a total of 490 gpm. Short right at 90 gpm with todays. Other supply problems with No. 3 there is some Iron and also that well is on manual controls. Storage: Total storage is broken down in Ground and elevated. You need 200 gpm per meter or per connection for a total of 193,200 gallons. You have in ground ground storage in two tanks totaling 51,000 gallons and the elevated is rated at 55,000 gallons. We are short 87,200 gallons, total storage. This shortage is also in the total storage but I have check ir separtely by itself. If you use elevated storage, you need for the Health Department, 100 gallons tank existing leaves a short on elevated storage of 41,600 gallons. If you cover this shortage provided that at least half of this is elevated.

Tom Goggans: All of this is based on 966 meters?
Mr. Johnson: Yes.

Service Pumps: You need at least 2 gpm per meter up to 1,000 gallons a minute. In our case we would need two pumps total 1,000 gallons a minute. We do not know what the rates capacity of the pumps are. First item would be to measure the discharge of the pumps. Lines for Domestic Water in General: 3/4" line will carry 1 meter, 1" line will carry 2, 2" line will carry 10 meters, 4" line will carry 100 meters and a 6" line will carry 250 meters. This is only a general guideline, when ever you get down to furnishing domestic water and being specific about it, you have considering how much water you are moving, how far you are going with it, and how high where you are going with it. You need to maintain a minimum of 20 PSI or a normal operation of 35 PSI. On fire, would be 500 gpm and delivered at a residual pressure of 20 PSI. Also to receive any consideration on insurance rates that line must have been put in before 1953 or it has to be a six inch or bigger. A six inch line running in float country will carry 500 gpm about 3200 feet before you drop down to hwere your pressure is no longer adequate to fight fires. That does not mean that you can not double feed a 4" line and put fire hydrants and give people fire protection. Other line

consideration: some of the lines are getting old and they were put in about 1935 and some of them are just coming apart and I believe that it is the smaller ones that are doing that. Another consideration is that you have one line across the railroad, which we have the 8" coming across. Existing lines are 4" and bigger. On U S 287, you have one 4", one 3" and 2 2" across the highway. I have laid out a plan, which may or may not be valid, but I have put additional elevated over on the east side of 287 and I have ran a 6" line from Well #3 over across the road and then ran it east across the railroad and down to this 6" line at the fire hydrant and brought it to the back of the 6" line on Mill Run Circle, which would give you a loop, and bring it back into the 4" that is hooked into the backup well. Crude Estimate: Construction: Supply-Well 150 gpm = \$73,000, No. 3 Controls-\$4,200, No. 3 Iron - \$3,600 and No. 4 Controls - \$6,300. Storage: Elevated Tank to take care of your total. Recommended to do on Elevated. Lines: 74,750. Total Construction - \$301,250., Site, \$51,200. Total \$352,450. Rate: Annual Payments Now = 40 years to FmHa, interest = 7 1/8%. On 360,000 27,396. year. Rates increase \$2.36 per meter. Engineer 7% of Construction Cost. This is what I see looking at your water system. This is all based on 966 meters.

Brannon Corporation - I am Terry Brannon of the Brannon Corporation - Existing since 1977, City of Tyler and City of Irving. Grannon Corporation has 33 employees and located in Tyler. We have 3 permanent survey crews, 8 staff engineers and 1 staff archertic. We have 3 computers. I head up the Water department for Brannon. We have worked on submitting 3 grant application for the City of Elkhart also we have worked on submitting plans for the Day Road Project and the Base Maps, Area Photograph, water and sewer and all this was done from a Planning Grant from TDCA. We have done more TDCA Projects in the State of Texas than any other firm in the State. We have prepared a detail study on the City. Information about Housing, Water System, Streets and Wastewater System. This study was done 2 years age. City of Elkhart has one of the highest key rates in the State of Texas for Fire Insurance. You have a 92 cents key rate. You have insufficient elevated and ground storage, insufficient well pumping. We do all the testing ourselves. I understand that the City of Eklhart is working on a bond program and a capital improvement to correct some of these problems. My best quote to you would be that it would cost between 1 million and 30 million dollars. To bring you in compliance

with the State of Texas Health capacity would cost about 379,000 dollars. Just to bring you up to date on the Fire Insurance and the Health Department it would cost you about 102,000 dollars and this is not to get you ahead. Jess Whitten has been the Engineer and we have not change that on you for the last 3 years. You will not get a bill from us until you authorize a project that you want.
