Failure to adhere to these policies may result in removal from the meeting. Members of the city council are prohibited from entering into deliberation. Under the laws of the State of Texas, the Council is not permitted to discuss non-agenda items. The Council is only permitted to recite statements of fact and city policies; no discussion is permitted.
