 - AN ORDINANCE OF THE ELKHART CITY COUNCIL OF ELKHART, TEXAS, AMENDING THE RECREATIONAL VEHICLE (RV) ORDIANCE 0-09092019-1, REGULATNG THE ESTABLISHMENT AND OPERATION OF RECREATIONAL VEHICLE PARKS (RV PARKS) AND INDIVIDUAL RECREATIONAL VEHICLES LOCATED WITHIN THE CITY OF ELKHART, PROVIDING FOR A SERABILITY CLAUSE; PROVIDING FOR A SAVING CLAUSE; PROVIDING FOR A PENALTY CLAUSE REPEALING ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; PROVIDING FOR AN ENGROSSMENT CLAUSE, PROVIDING FOR PUBLICATION IN THE OFFICIAL NEWSPAPER, AND PROVIDING AN EFFECTIVE DATE.

PENALTY: Any person(s) violating the ordinance shall be subject to fine not to exceed Five Hundred Dollars (\$500.00) for each provision violated, and each day that there is failure to comply with the terms of any provision of this ordinance is declared to be a separate offense. For violation of the provisions of the ordinance that govern fire safety, zoning, or public health sanitation, including dumping or refuse, the fine may not exceed Two Thousand Dollars (\$2,000) per day, per violation. The code official shall be the authority of the jurisdiction responsible for the issuance of citations and any actions deemed necessary for the enforcement of this ordinance.
