A. CALL TO ORDER, PLEDGE, AND INVOCATION

With a quorum present, a Regular Meeting of the City of Elkhart City Council was called to order by Mayor Pro Tem Chuck Conner at 6:03 p.m. at City Hall 110 West Parker Street, Elkhart, Texas 75839. Mayor Jennifer McCoy was running late. Invocation was given by Councilmember James Warren.

C. REGULAR AGENDA

1. Discuss and take action, if any, concerning policies for water usage in regards to filling residential pools.
